Development of a Global Strategic Agenda for ARD aimed at facilitating the emergence of a new normative framework for agricultural research

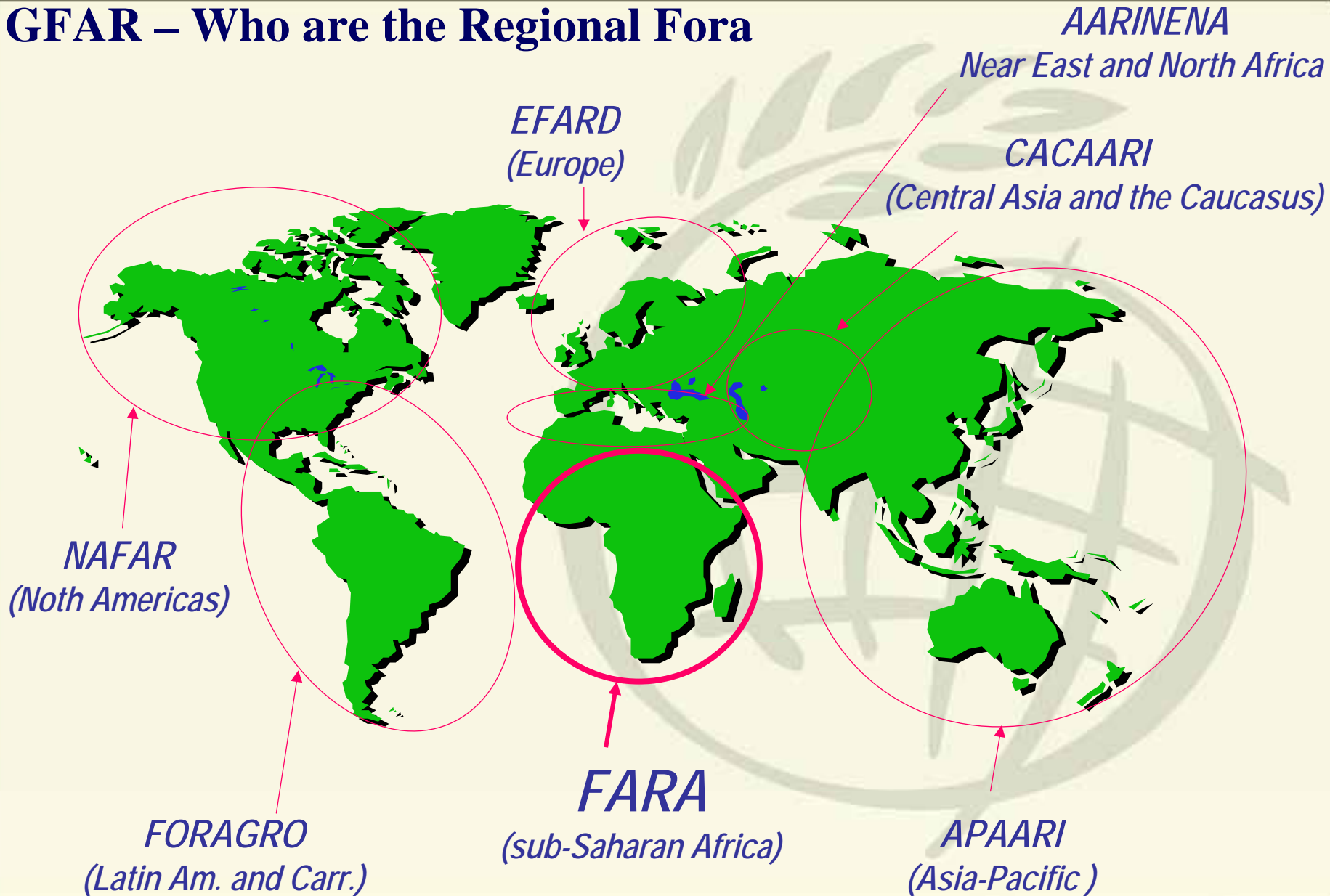


Facilitate the development of networking and research partnerships among stakeholders in topics of common interest

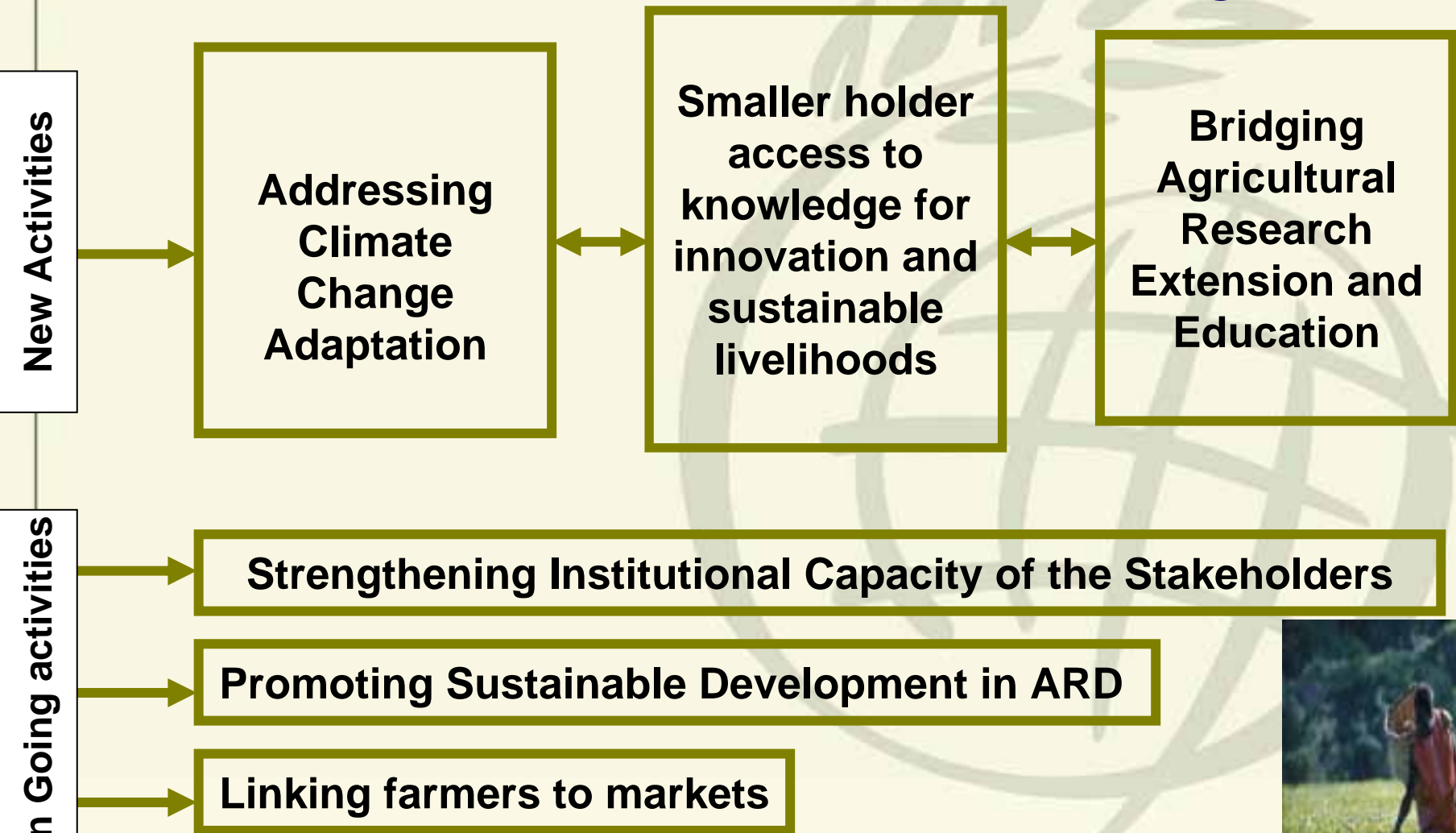
